AUDIT EXECUTIVE SUMMARY:

Review of the food safety management system and good manufacturing practices in a cooling and cold storage operation dedicated to receiving packed product from fields (Table grapes) and others from packing facilities (citrus) and with the following flow chart: Receiving; palletizing wrapped; customer request SO2 Fumigation (California table grapes); Cold Storage and Shipping. Operation is located in Delano, CA. The cold storage has a space of 160000 square feet of cooling space. No hydro-coolers or Vacuum tubes used; Forced air used in cold rooms. Employees observed following the GMP policies, documentation is kept at the main office, organized and readily accessible for inspection. Receiving area, break room, restrooms were inspected along with surroundings. 20 employees on duty, with a top of 25. Conventional product handled. This facility works year around. This is a Cooling facility which works as a cold storage which have a cold room called PR1 dedicated for packing mixed grapes in clamshells, however, will be audited in an separate audit. No major issues found in this operation. This was an unannounced audit.
